Weekly Vendor Fee: \$75 for a 10' x 10' booth space (due 2 weeks prior to market day)

Mandatory: \$50 Deposit (refundable upon complete season / sales tax payments)

Cancellation Deadline: July 1st. No refunds after this date.

- Booth space is 10X10. We suggest a strong, weather-resistant, professional tent with weights, walls and a roof. There will most likely be some weather and you need to protect your art as best as possible.
- No factory made items, machine molded items or imports. All work must be your design, crafted by you and represent your own artwork. Reproduction of your *own* artwork is accepted.
- **Please be aware booth locations may rotate each week and artists who participate the entire season are given preference to more consistent booth placement.**
- **Event Parking:** All artists can either park at the Nordic Center or nearby residential streets.
- *Parking in the 1<sup>st</sup> Street/Elk Ave lot is for Patrons Only.* Please note we want to make this event accessible for guests at both Markets.
